The GCSDD Board is seeking input from the community about development of its Burnham Strip parcel, a seven-acre lot along the south side of Obispo Road between Coronado

Daniel Burnham, the famed architect who designed El Granada over 100 years ago. The Board is committed to broad and extensive community engagement in planning the Park.



Street and the Picasso Pre-School, into a community park. A portion of the parcel is currently used as a parking lot, mostly by visitors to Surfer's Beach, and about two acres of the property are protected wetland. The GCSDD property is bordered by the Caltrans right-of-way along Highway 1.

The Burnham Strip property boasts breezy ocean views and three significant riparian areas. GCSDD has worked with its environmental partner, the San Mateo County Resource Conservation District, to remove invasive species and restore natural flora in the riparian areas. The GCSDD Board is now planning to develop Burnham Park—named for

GCSDD first presented ideas for the park at a public event on the property in June 2018, collecting detailed comments from more than seventy people about what they did and did not want in the Park. More than 85% of those who provided comments supported development of the new community park. GCSD Board Investigates Possible Community Recreation Center

At its August meeting, the GCSD Board agreed to appoint a negotiator to investigate the possibility of acquiring the old El Granada Fire Station for potential use as a GCSD Community Center. This building is desirable because of its location in “downtown” El Granada, and its proximity to the future Burnham Park (across the street). Having

GCSD Parks Advisory Committee (PAC) Forms Bicycle Pump Track Task Force

PAC members have been keeping abreast of San Mateo County (SMC) Parks’ communications and delayed approvals for the Quarry County Park Master Plan. The Master Plan proposal presented at the last public meeting, in April 2018, included a bicycle pump track. The GCSD Board has offered SMC Parks unspecified financial support for a bicycle pump track, and has assigned PAC to advocate for the track. At a recent Midcoast Community Council (MCC) meeting, SMC Parks acting director Peggy Jensen suggested the Quarry Park Master Plan may finally reach approval in early 2020.

ment of a County Quarry Park Pump Track proposal. This will include outreach for potential collaboration with the SMC Parks Foundation, and considerations such as the pump track size and location, critical design elements, cost estimates, permit requirements and volunteer-supported building and maintenance.



A bicycle pump track is a continuous loop of dirt berms and “rollers” (smooth dirt mounds). The rider’s upper and lower body’s pumping motion maintains the speed around the track, ideally without pedaling.

GCSD Sewer Service Charge Information

The District charges an annual flat-fee for residences connected to the public sewer system. Each fiscal year, the fee is collected on the San Mateo County tax roll, in the same manner as property taxes and other assessments. The District’s Sewer Service Charge for fiscal year 2019/20 is \$520.

The revenue raised from the Sewer Service Charge is used to pay for the costs of maintenance and operation of the District’s wastewater facilities used for the

collection, conveyance, treatment, and disposal of wastewater, including the District’s share of the cost of operation and maintenance of the Sewer Authority Mid-Coastside wastewater treatment plant facilities, and for expenditures deemed necessary to conduct District business.

Mission Statement

To protect public health and safety, preserve our environment, and maintain fiscal soundness by providing high quality service for wastewater, solid waste collection, recycling, and serving the community's needs for parks and recreation, through responsible operations and management.

About the District

The Granada Sanitary District was formed in 1958 under the California Sanitary District Act of 1923 (California Health & Safety Code Sec. 6400). In October of 2014 the District was reorganized as the Granada Community Services District by a vote of 60% of the residents. The District is now responsible for parks, recreation, garbage and recycling services in the unincorporated areas of El Granada, Princeton, Princeton-by-the-Sea, Clipper Ridge, and Miramar. The parks function is funded with the District's portion of property taxes.

The District is also responsible for the sewage collection system and its portion of the Sewer Authority Mid-Coastside sewage treatment plant for approximately 2,500 residences and businesses in the District, including the northern portion of the City of Half Moon Bay. Garbage and recycling services are provided by Recology of the Coast under a franchise agreement with the District.
