MEETING NOTES CITY OF HALF MOON BAY BICYCLE AND PEDESTRIAN ADVISORY COMMITTEE

SPECIAL MEETING THURSDAY, JANUARY 21ST, 2021 6:30 P.M.

I. INTRODUCTION

Chair Mario Rendon welcomed the Committee and members of the public.

Roll Call:

Present (All): Brown, Dragony, Eisen, Foldenauer, Gater, McMillan, Murray, Ruddock, Vice-Chair Etherton, Chair Rendon

The meeting agenda, and the 11/5/20 meeting notes, were accepted. The 2021 BPAC meeting calendar was distributed; it is posted on the City's website.

II. PUBLIC FORUM – NON-AGENDA ITEMS

Attendees: Bob Nisbet, Jim Sullivan, Matt Nichols.

Comments: The important work of BPAC members is appreciated; City Council decided to initiate the Coastside Recovery initiative presented at Tuesday's City Council meeting; open house scheduled for February 11th @ 6:00 p.m..

III. AGENDA ITEMS

City Engineer Maz Bozorginia provided PowerPoint presentations and answered questions about the following items:

(1) TFCA Main Street Traffic Safety Project

The Committee agrees with the TFCA project; there were positive comments about the high-visibility crosswalks and the reduction of the number of poles. Public comment, questions, and discussion included: Designation of green lanes (no); warning systems and highly visible road decals, spending deadlines; the advantages of integrating/investing in technology such as the

Waze application vs. physical changes in the field; and signs directing to free parking downtown.

(2) E-bikes and trails

The Committee acknowledged of letters from the public, received public comments, discussed numerous items, and agreed with the benefits of e-bikes. The consensus of the Committee is to support the recommendation to allow e-bikes and to align Half Moon Bay's policy with that of the State Parks.

Public comment: Importance of allowing riders to commute and recreate on trails away from vehicles; issues of enforcement of (1) speed and (2) type of e-bikes allowed; these are an alternative means to motor vehicles; e-bikes allowed in the GGNRA and State parks; trail etiquette; accessibility and inclusivity; some cannot appreciate the trail without e-bikes; need for bike bells, signage, "slow and say hello" education; County Parks ranger staff patrols Pillar Point bluffs and quarry parks on e-bikes; Devil's Slide Trail has an active Trail Ambassador program; speed limit everywhere is 15 m.p.h.; speed bumps; flashing lights, road decals.

Committee questions/discussion: Coastal Trail traffic and speed concerns; what is considered a city trail and what would be compatible with e-bikes?; the lack of authority/oversight on the trail; what mechanism for enforcement -- Sheriff's office, volunteer/ambassador program or city staff; a non-City, volunteer entity should be considered; economics of tourism/source of revenue; need to align with, as well as collaborate and coordinate with State Parks; striping and signage, including a median stripe and signage about where bikes are available and where you can ride; enforcement challenge caused by determining bike type (it is difficult to tell the difference between class 3 and class 1 and 2 bikes); speed is the issue and not the class of bikes; Sheriff's department does not patrol the trail on bikes--could they add bikes to their equipment?; this will be a balance that includes signage and a campaign; trail traffic and use of e-bike rentals will intensify with time; COVID has brought more visitors to the coast; we are a destination point during COVID; balance residential needs with the lifeblood of the tourists and at the same time the brace for the summertime influx; a number of conditions at the State Parks level that have affected communication, including COVID, fires, furloughs, a retirement "brain drain", and new director.

(3) Updates about the Hwy 1 South project and BPMP Small Projects List

After the presentation, the Committee discussed Caltrans policies, need for a reciprocal relationship with Caltrans, the role of BPAC in facilitating this coordination between Caltrans and other state agencies such as State Park (advisory role to council, City Council is the appropriate body to coordinate w/ Caltrans and State Parks); scheduling joint meetings between Parks & Recreation and BPAC in the interest of time.

IV. FUTURE AGENDA ITEMS

Better communications with State Parks and Caltrans were suggested.

V. COMMITTEE REPORTS/COMMENTS

Committee member Etherton received an e-mail Emma Spaeth, of Silicon Valley Bicycle Coalition (SVBC) about the formation of local bike groups. One is forming for the north county - Brisbane, Daly City, South San Francisco, San Bruno, and Millbrae, if anyone is interested in joining. She suggested SVBC as a resource for ambassador program. Committee member Gator is a member of SVBC and was a part of the kick-off meeting; he noted SVBC would like to establish a coastside group in the future.

Committee member Steve Ruddock noted he has been BPAC's Planning Commission appointed Representative for two years; Planning Commission is appointing a new representative, so this is his last meeting. He applauds the passion and energy this group has brought to bikers and pedestrians; it's been a real pleasure for him; wishes good luck with this charter.

VI. ADJOURNMENT

TITLE: RESTRUCTURING OF THE CITY OF HALF MOON BAY BICYCLE / PEDESTRIAN

ADVISORY COMMITTEE

RECOMMENDATION:

That the Committee provide input to staff on the potential restructuring of the City Bicycle / Pedestrian Advisory Committee (BPAC).

BACKGROUND:

On March 7, 2017, the City Council affirmed the formation of a BPAC and provided direction that the Committee consist of 10 members, including the following:

- 1. One (1) walking enthusiast;
- 2. One (1) commute dependent cyclist;
- One (1) recreational cyclist;
- 4. One (1) avid cyclist;
- 5. One (1) at-large community member;
- 6. One (1) senior representative;
- 7. One (1) youth representative;
- 8. One (1) member of the Parks and Recreation Commission chosen by its membership;
- 9. One (1) member of the Planning Commission chosen by its membership; and
- 10. One (1) representative of the Cabrillo Unified School District appointed by the District.

This structure was created and recommended by staff to serve as an ad hoc Steering Committee for the Bike and Pedestrian Master Plan. This Master Plan was adopted by the City Council in September 2019. With the adoption of the master plan, the original BPAC steering mission was fulfilled.

Over the last two years, staff has been asked to consider changing the make-up of the Committee. Notably, the Planning Commission has asked to be relieved of its seat.

DISCUSSION:

The City Council is scheduled to appoint/re-appoint representatives to the Bike Pedestrian Advisory Committee in April. Terms of appointment for the BPAC are for four (4) years as adopted by the committee bylaws. In light of this, staff is taking the opportunity to look at the current make-up of the Committee and to consider potential changes to the Committee based upon the current and anticipated role. Most policy questions are:

- 1) The Committee has evolved from the ad hoc Steering Committee to assisting in the implementation of the City's Master Plan;
- 2) With this transition, should all appointees to the City BPAC be residents of Half Moon Bay;
- With the transition of the City Council to district elections, there is a policy question as
 to whether BPAC appointments should include representation from all four districts and
 an at-large basis;
- 4) Should the Planning Commission and Parks and Recreation direct appointees be eliminated on the basis that most projects come to one or both Commissions prior to implementation (and some appointees have questioned the need for their participation in the BPAC); and
- 5) Should the CUSD appointee be an ex-officio (non-voting) member of the Committee.

While staff has not formalized its recommendation, we are anticipating recommending a BPAC that is more in line with Commission memberships. Staff envisions a BPAC comprised of 5-7 residents/voting members continuing to represent of all residents of Half Moon Bay. We are interested in your input on the matter.

We recognize that the actions being discussed may very well result in the elimination of some of your own positions. We beg of you to not draw conclusions that staff is unhappy with Committee members or does not believe the Committee has and continues to represent the coastside well. Staff believes that after four years of operating along with changes in focus of Committee warrants a deeper assessment.

Also, it is important to recognize that the current City Council may wish to consider new individuals regardless of Committee re-structuring. Thank you for your consideration and comments.
