**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF “NO PARKING” ZONES  
ON PURISIMA CREEK ROAD AND HIGGINS CANYON ROAD, IN  
UNINCORPORATED HALF MOON BAY**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, California Vehicle Code Section 22507 et al. and Section 7.30.010 of the County Ordinance Code allow the Board of Supervisors to prohibit or restrict the stopping, parking, or standing of vehicles by resolution or ordinance; and

**WHEREAS**, the Department of Public Works received a “Parking Restriction Request” from Midpeninsula Regional Open Space District requesting parking restrictions along Purisima Creek Road and Higgins Canyon Road in unincorporated Half Moon Bay; and

**WHEREAS**, the parking restriction would extend the current “No Parking” zone already in place and further prevent visitors to the Purisima Creek Redwoods Preserve from parking alongside the roads and allow open and clear roads for residents and emergency vehicles; and

**WHEREAS**, property owners on adjacent blocks, extending a minimum of 300 feet from the proposed parking restriction zone were notified of this Board’s meeting and comments received to date in in favor of this change; and

**WHEREAS**, the Director of Public Works has recommended that a “No Parking” zone be established as noted herein; and

**WHEREAS**, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

**IT IS FURTHER DETERMINED AND ORDERED** that:

1. "No Parking" Zones be established at the following locations:

On Purisima Creek Road (Road 41), unincorporated Half Moon Bay, approximately three hundred seventy-five (375') feet south of the centerline of Higgins Canyon Road, on the southerly side of Purisima Creek Road continuing for three thousand two hundred thirty feet (3,230') feet, more, or less.

2. On the northern side of Purisima Creek Road (Road 41) beginning three hundred seventy-five (375') feet south of the centerline of Higgins Canyon Road begins a "No Parking Zone" for three thousand two hundred thirty (3,230') feet, more, or less.

3. A "No Parking Zone" be established at the following location:

Higgins-Purisima Road (Road 39B), unincorporated Half Moon Bay, beginning fifty (50') feet west of the centerline of Purisima Creek Road then traveling in a westerly direction on both sides the road for one thousand seven hundred (1,700') feet, more, or less.

4. The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
